The Chairman and Member are requested to serve on the Board. The Co-ordination Board shall visit each college of Education as per the programme enclosed to this Notification. The Board shall scrutinize the records and Internal Assessment sheets of all the candidates, and suggest measures to modify the marks in accordance with the decision of the Board. The Board shall have the power to modify the individual marks of the candidates only in case where the marks are abnormally high or low in the opinion of the Board. The Board shall have the power to interview such candidates.

The Principal of each college shall submit the entire list of marks of internal assessment to the Chairman when the Board visits the college. The Principal of the College shall resubmit the internal assessment marks only after incorporating the suggestions made by the Board, if found necessary.

The Chairman of the Board shall scrutinize the modified list in the light of the suggestions made by the Board and will certify the consolidated marks list and hand over the same in a sealed cover to the Principal concerned. The Principal of the college concerned shall submit the above said marks list to the Registrar (Evaluation) on the same day. The entire process should be completed within one week from the date of visit to the college.

A sum of Rs. 10,000/- (Rupees Ten Thousand only) is sanctioned as an advance to the Chairman of the Committee. The expenditure may be debited to the Head of Account No. 1009. The TA/DA will be paid to the Members of the Board as per the University rules.
